Area School Review: Brynford, Lixwm & Rhosesmor



Background

In June 2015 Cabinet determined that we enter into informal consultation for an area review for the following schools:

- Brynford C.P School
- Lixwm C.P. School
- Ysgol Rhos Helyg, Rhosesmor

The area school review will assess the education provision in the area of Brynford, Lixwm and Rhosesmor.

The options for the area are as follows:-

- Option 1 : Status Quo
- Option 2 : Area School on One Site
- Option 3: Retain Ysgol Rhos Helyg, Rhosesmor and one Area School on one site (either Brynford C.P. or Lixwm C.P. School).

This would mean the following:-

- **Option 1 : Status Quo** Each school remains as it is, retains its name, category, budget, governors, staff and remains in its community.
- Option 2 : Area school on one site Area school one site, the school would retain its category but would have a new name, governing body, head and budget and would remain in one of the communities either Brynford, Lixwm or Ysgol Rhos Helyg, Rhosesmor.
- Option 3 : Area Schools on two sites Ysgol Rhos Helyg, Rhosesmor would remain as it is, retains its name, category, budget, governors, staff and would remain in its community. Brynford C.P. and Lixwm C.P. would amalgamate onto one site. The amalgamated school would remain in one of the communities either Brynford or Lixwm.

Purpose


The purpose of the Equality and Welsh Language Impact Assessment is to identify how the potential options for the area school review would affect those with protected characteristics, both positively and negatively.


The Equality and Welsh Language Impact Assessment includes:

Impacts Page

If Option 1 is chosen there will be no impacts as the school will remain in its current form;

If either Option 2 or 3 is chosen, potential impacts for schools not chosen to host an area school include:

- Possible decrease in event attendance due to access to transport;
- Possible longer and shorter distances to travel to school for stakeholders;
- Loss of employment;
- New school uniform;
- New teachers and support staff for pupils;
- New and unfamiliar learning environment;
- Changes to friendship groups
- Disruption to all pupils with additional learning needs (ALN);
- Replicating support for pupils with ALN in their new learning environment
- Cost of implementing any required adaptations
- Redundancies for both men and women;
- Increased travel time for staff who are successfully redeployed;
- Individuals may be in lesbian, gay or bisexual relationships, or have undertaken gender reassignment and transition may be challenging to a new school environment;
- Closure of the buildings removing them from community use;
- Increased costs of new school uniforms for transferring pupils.

Potential Actions to Mitigate Impacts

- Providing transition support to pupils
- Providing regular information and support to all pupils, their families, staff, and governors, especially those with protected characteristics
- Providing access to a school uniform exchange programme
- Providing Inclusion Services support for pupils in particularly those with additional learning needs
- Providing access to both English and Welsh medium schools as well as faith education if desired
- Providing specialist interrelated services
- Providing Counselling Services, Sensory Services, English as an Additional Language / Gypsy Traveller Service, Additional Learning Needs Service, Speech, Language & Communication Service, Education Welfare Service, Behaviour Support Service, Education
 Otherwise Than At School and Autistic Spectrum Condition Service
- Redeployment and redundancy support should this be required
- Consulting staff through 1:1 meetings
- Community impacts mitigated through fostering wider community links depending on the options selected
- Consider asset transfers to a constituted community groups where they can demonstrate a need and ability to take over the running of the site;
- Development of a new Gender Reassignment Policy and subsequent training.
- Providing training via the Stonewall Education Champions Programme;
- Taking all practicable steps to minimise disruption

What we will do next.

We will informally consult on the area school review with the affected school communities including getting children and young people views. Information from the informal consultation will be provided to Cabinet in Autumn 2016 together with the Impact Assessments. Cabinet will carefully consider all the information, prior to deciding which option to pursue for the area.

Post Cabinet determination, further information will be made available to stakeholders.
