
In all other respects the present provisions of The Flintshire County Council (Off Street Parking Places – Buckley) (Revocation) Order 2018 will remain in force.



### STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The effect of the proposed Order, is to regulate the use of Brunswick Road Car Park in Buckley, by introducing an area of free parking provision, to improve the vibrancy and vitality of the town centre by providing free short stay parking.
