

NOTICE OF PROPOSED DISPOSAL OF PUBLIC OPEN SPACE LAND

In compliance with section 123 (2A) Local Government Act 1972, Flintshire County Council gives notice that it intends to dispose, by the grant of a lease, of **open space land at Golftyn Park, Church Street, Connah's Quay, Deeside**, for a term of 10 years at a peppercorn rent, for the tenant to carry out works and to be used as an area for public recreation, education, volunteering and similar activities to serve the local communities.
