

Elfen allweddol o'm rôl fel Comisiynydd Heddlu a Throsedd Gogledd Cymru ydy gosod y praesept blynyddol, sef cyfran y Dreth Gyngor sy'n talu am blismona. Mae lefel y praesept yn penderfynu cyfanswm yr arian sydd ar gael ar gyfer plismona Gogledd Cymru. Mae tua hanner yr arian ar gyfer plismona yn dod o'r Dreth Gyngor, a'r hanner arall yn dod o Lywodraeth y DU drwy'r Swyddfa Gartref.

Yn dilyn arolwg gynhaliwyd efo preswylwyr a pherchenogion busnes Gogledd Cymru, a dderbyniodd dros 1,300 o ymatebion – a chyda chytundeb Panel Heddlu a Throsedd Gogledd Cymru – mi fydd cynnydd o 50c fesul wythnos (neu £26.10 y flwyddyn) yn y Dreth Gyngor ar gyfer eiddo Band D yn y flwyddyn ariannol 2026-27. O ran canran, golygai hyn gynnydd o 7% o'i gymharu â llynedd, ac mae'r swm cytunwyd arno yn dod i rym ar 1 Ebrill 2026.

Nid ydy fy mhenderfyniad i gynyddu'r praesept Plismona ar eiddo cyffredin yn 2026/27 wedi bod yn rhwydd. Dwi'n gwybod bod llawer o bobl a theuluoedd methu ymdopi â chostau byw. Mae hyn yn rhywbeth dwi'n weld a chlywed yn ddyddiol wrth i mi ymweld â chymunedau ledled Gogledd Cymru fel CHTh, ac fel Cynghorydd Cymunedol yng Nghei Connah. Mi wnaed yn amlwg i mi hefyd gan y bobl wnaeth fynychu fy nigwyddiad ymgysylltiad cyhoeddus, sef Bys ar y Pwls. Mi ymwelais â Bangor, Rhuthun, y Fflint, Wrecsam, y Bermo a Bae Colwyn cyn gosod y praesept.

Dwi wedi fy ngwreiddio yn ein cymuned ni, a dwi eisiau'r gorau oll iddi, yn gymdeithasol ac yn economaidd. Rhan hanfodol o gyflawni hyn ydy drwy sicrhau bod gynnon ni Wasanaeth Heddlu effeithiol ac sydd wedi'i ariannu'n dda. Os oes gynnon ni ddigon o arian ar gael, dwi'n gobeithio gweld buddsoddiad mewn nifer o feysydd mae pobl o hyd yn dweud wrtha i maen nhw eisiau gweld gwelliant, megis ymateb yr Heddlu drwy 999 a 101. Golyga hyn fuddsoddiad yng Nghanolfan Reoli'r Heddlu, fydd yn helpu gwella amseroedd ymateb. Dwi hefyd yn gobeithio gweld buddsoddiad yn yr Uned Fforensig Digidol, fydd yn helpu datrys troseddau. Hefyd yn yr Uned Gwarchod Unigolion Bregus, sy'n ymchwilio rhai o'r troseddau mwyaf difrifol, ac sy'n helpu a gwarchod aelodau o'r cyhoedd sydd fwyaf agored i niwed.

Mi roedd aelodau'r cyhoedd gymerodd rhan yn fy arolwg a mynychu fy nigwyddiadau Bys ar y Pwls yn eglur ynglŷn â'r angen i roi'r offer cywir i'r Heddlu ar gyfer cyflawni'u gwaith a'n gwarchod ni. Dwi'n gobeithio bydd y cynnydd yn y praesept dwi'n gynnig yn helpu'r perwyl hwn, ynghyd â fy mlaenoriaethau allweddol o bresenoldeb plismona cymdogaethau lleol; helpu dioddefwyr, cymunedau a busnesau; a system cyfiawnder troseddol deg ac effeithiol.

A key aspect of my role as Police and Crime Commissioner for North Wales is to set the annual precept, which is the portion of Council Tax that pays for policing. The level that the precept is set at determines the total amount of money available for policing in North Wales. Around half of the funding for policing comes from Council Tax, with the other half coming from the UK Government via the Home Office.

Following a survey that took place with residents and business owners of North Wales involving over 1,300 responses – and with the agreement of the North Wales Police and Crime Panel – there will be a 50p per week (or £26.10 per year) increase in Council Tax for a Band D property for the financial year 2026-27. In percentage terms, this means a 7% increase on last year and the agreed amount is effective from 1 April 2026.

My decision to propose this increase in the Policing precept for an average property for 2026/7 has not been an easy one. I know that many people and many families are struggling with the cost of living. This is something I see and hear day-in, day-out as I visit communities across North Wales as PCC and as a Community Councillor in Connah's Quay. It was also made clear to me by those who came along to a six-location public engagement event called the People's Pulse I held before setting the precept and which visited Bangor, Ruthin, Flint, Wrexham, Barmouth and Colwyn Bay.

I am rooted in our community and I want the very best for it, both socially and economically. And a vital part of achieving this is through ensuring we have a well-funded and effective Police Service. If we have sufficient funding available, I hope to see investment in several areas that people tell me all the time they want to see improved, such as Police response via 999 and 101. This means investing in the Force Control Centre, which will help improve response times. I also hope to see investment in the Digital Forensics Unit, which will help in solving crimes and in the Protecting Vulnerable People Unit, which investigates some of the most serious crimes and supports and protects members of society at highest risk of harm.

The members of the public who took part in my survey and attended my People's Pulse events were clear about the need to give Police the right tools to get their job done and to protect us. I hope my proposed increase to the precept will help in this mission and my key priorities of a local neighbourhood policing presence; supporting victims, communities and businesses; and a fair and effective criminal justice system.

Cymharu lefel y Gyllideb Refeniw â chanllawiau Llywodraeth Cymru

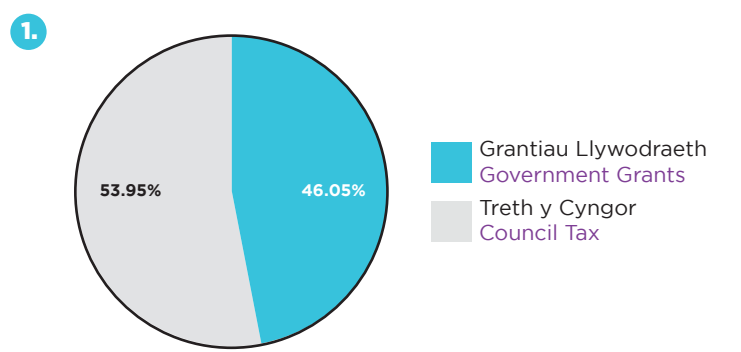
Gan ddefnyddio fformiwla a luniwyd ar gyfer pob Heddlu yng Nghymru a Lloegr, mae Llywodraeth Cymru a'r Swyddfa Gartref wedi cyflwyno "safon gwariant" a elwir yn Asesiad Gwariant Safonol (AGS) a Grant yr Heddlu o £153.270m ar gyfer 2026-2027. Dyma yw asesiad y Llywodraeth o'r hyn y bydd angen i'r Comisiynydd ei wario er mwyn darparu'r un lefel o wasanaeth a chomisiynwyr eraill yng Nghymru os ydynt hwythau hefyd yn gwario yn unol â chyfanswm eu AGS a'u Grant Heddlu eu hunain.

Mae gan y Comisiynydd hawl i wario mwy na chyfanswm yr AGS a'r Grant Heddlu, gyda'r gwahaniaeth yn cael ei ariannu gan y Treth Cyngor neu o'r Cronfeydd Wrth Gefn. Mae'r Comisiynydd wedi penderfynu ar ofyniad Cyllideb o £227.911m.

How much of your council tax is spent on policing?

There are nine council tax bands in North Wales, based on the capital value of the property in 2003.

\*Band D is used for National comparisons of tax levels. From a Band D Council Tax bill, only £398.25 is allocated to funding the Police service of North Wales, as agreed by the Police and Crime Commissioner for North Wales.

Therefore, depending on your property band, the amount from your Council tax bill which funds the Police Service of North Wales is as follows:

Comparison of the level of the Revenue Budget with the Welsh Government's guidance

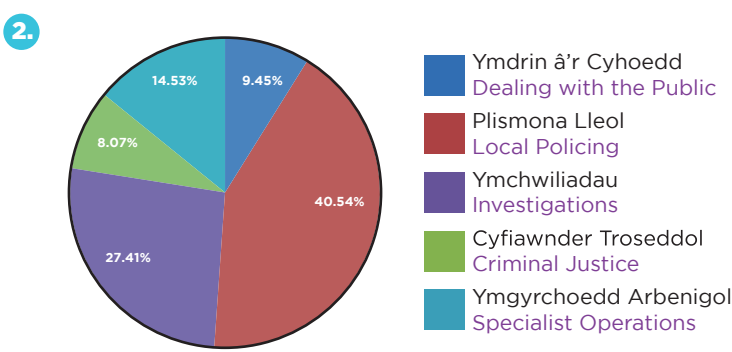
Using a formula developed for all Police Forces in England and Wales, the Welsh Government (WG) and the Home Office have issued a "spending norm" known as the Standard Spending Assessment (SSA) plus Police Grant of £153.270m for 2026-2027. This is the Government's assessment of the Commissioner's need to spend in order to provide the same level of service as other commissioners in Wales if they also spend at the level of their own SSA plus Police Grant.

The Commissioner is allowed to spend in excess of its SSA/ Police grant total, with the excess being funded from the Council Tax or Reserves. The Commissioner has set a Budget requirement of £227.911m.
