### WHO ARE THE YJS

The Youth Justice Service (YJS) is a service that supports young people to reduce their risks of offending. We also work closely with schools, police, probation, social services and health.

#### WHAT HAPPENS NEXT?

You will be contacted by a YJS
Officer in the next 24-48 hours who
will arrange to see you to complete
an assessment.

The assessment will look with you, your parents and other agencies (school, police, social services) at your offending and things that are going on in your life to identify ways in which the YJS and others can help.

You will then be asked to draw up and agree a plan with the YJS, parents and other agencies to help you address your offending and develop your aspirations for the future.

# WHAT WILL BE EXPECTED OF ME?

You will be expected to attend all of your appointments with the YJS and participate in these sessions. Maintain contact with the YJS. You should also tell us if anything changes in your life and you can also speak to us about anything worrying you or that you are concerned about.

### WHAT WILL BE EXPECTED OF MY PARENTS / CARERS?

Support your child to attend all appointments and attend any assessments.

Maintain contact with the YJS.

You should also tell us if anything changes in your life and you can also speak to us about anything worrying you or that you are concerned about.

# WHERE WILL MY APPOINTMENTS TAKE PLACE?

They could be at home, school, or in the community. But normally this will be discussed and agreed with you and your parents or carers.

## WHAT HAPPENS IF I CAN'T ATTEND MY APPOINTMENTS?

Contact the YJS immediately on 01352 701125. If you miss an appointment. If you miss an appointment you could be given a warning and returned to Court.

#### NON-COMPLIANCE

The YJS is responsible to the court for making sure that the court order is carried out. The young person is required to keep all appointments and to abide by behaviour rules during appointments.

Failure to do this, without an acceptable reason, can lead to a return to court for 'breach' of the order. If the young person is taken back to court for breach, the court may decide to revoke (cancel) the order and to re-sentence the young person
