At a recent meeting of the Council it was reported that further consultation and meetings had taken place with parents, guardians and teaching staff of Lixwm C.P. School in regard to the above programme.

I have been instructed to write and advise of a number of concerns that have been reported to members of the Council as follows:-

1. The report setting out the impact and future needs of the community was not accurate as it did not include ongoing residential development within Lixwm.
2. No bilingual information was provided and the online ongoing consultation is not available bilingually.

In light of this the Council would consider it to be appropriate to commence the start and finish of the time frame for the consultation from when the bilingual version is available. The Council would welcome confirmation of receipt of this letter and your observations to the concerns raised.

**Area School Review (Brynford, Lixwm and Rhosesmor)**

I refer to your letter dated 24<sup>th</sup> July 2016 regarding the area school review of Brynford, Lixwm and Rhosesmor.

The Community Impact Assessment does have regard to local housing development's. However, the plans only take into account housing developments which have full Planning approval. At May 2016, the Planning Directorate advised that there were no approved applications for housing developments with the village of Lixwm.
