1/ Welcome -

TW introduced himself and his role as Secretary to the Local Access Forum and as interim Chair, welcomed everyone to the meeting.

2/ Introductions -

Each member introduced themselves and gave a brief overview of their background and interest in the forum.

3/ Setting the Scene -

TW introduced the agenda of the meeting and set the background and context to the establishment of this new Flintshire Local Access Forum.

He explained the Access Team would support the running and administration of the Forum.
