**NOTIFICATION OF THE WELSH MINISTERS' INTENTION TO PROVIDE  
OR IMPROVE A TRUNK ROAD**

Notice is hereby given under Article 19 of the Town and Country Planning (Development Management Procedure)(Wales) Order 2012 (SI 2012/801 W.110) that the Welsh Ministers propose to construct a new length of trunk road to the north-east of the existing A55 Northop junction and north-west of the A494 through Deeside to the Wales/England border in the County of Flintshire as follows:-

A route about 12.65 kilometres in length commencing to the west of Junction 33 of the A55 trunk road known as Northop Junction, north of Northop, to include a 1,300 metre length of remodelled Junction 33a and then extending in a north-easterly direction for 3,000 metres to include a new roundabout at Kelsterton and then continuing 700 metres in an easterly direction linking with the existing A548 Flintshire Bridge river crossing of the River Dee. The route then continues in a northerly direction for 2,725 metres to a proposed Weighbridge Road junction and follows the existing A548 for 1,275 metres to a point where the existing alignments separates with the A548 and links with a new junction at Parkway before continuing to the Wales/England border (the intention being that the route would continue to tie-in to the existing A494 just after the Wales/England border in the north of England at a new interchange known as Shotwick Interchange), as indicated on the attached TR111 Route Plan Drawing No: 60436462-400-410-03-0003/A55-A494-A548 TR111 No. 1-2018, dated September 2017.

Any planning application or local authority proposals for development affecting land within 67 metres of the proposed route or improvement should be referred to the Welsh Government in accordance with the above-mentioned Article.

As from the date of this notification affected properties may fall under Section 149(1) of and paragraphs 13 to 18 of Schedule 13 of the Town and Country Planning Act 1990 and the above proposals should, therefore, be revealed in searches.
