# **Consultation on Environment White Paper**

Wales needs new legislation to ensure its natural resources are managed in a sustainable and joined up way according to Minister for Natural Resources and Food, Alun Davies. The Minister was speaking about his newly published Environment Bill White Paper and said that the draft legislation would be key in delivering long term prosperity for Welsh communities and ensuring sustainable economic growth. The proposals have been designed to strip away unnecessary complexity in current environment legislation, simplify processes and plans and deliver a more joined up approach to natural resource management. #### New survey shows Welsh Woodlands are seen as a community resource

Nearly 65% of people in Wales visit Welsh woodlands regularly and 94% believe they provide a definite benefit to the local community. This is according to this year's Public Opinion of Forestry Survey, which has been carried out every two years since 2003 to track people's opinions on Welsh woodlands and to assist managers in deciding where improvements can be made. The new Access Broadband Cymru scheme will offer funding towards the delivery of faster broadband connections for businesses, residents and communities across Wales. Launched on 1 October 2013, the scheme is targeted specifically at premises that currently receive slow broadband.

# **Connected to nature?**

For the first time ever, a study to determine how connected UK children are to nature has been carried out, and highlights that children in Wales score significantly lower than the rest of the UK. A three-year research project, undertaken by the RSPB, found that only 13% of children (1 in 8 children) in Wales have a 'realistic and achievable' level of

The Community Generation Fund is a national fund created to provide a catalyst for the widespread development of community-owned renewable energy infrastructure. The Fund aims to provide access to capital at project stages or scales where funding is needed most but is not readily available. The fund is not a grant or "low / nil cost" scheme. The Fund will consider project sizes from 25kWp capacity upwards, subject to assessment of technical viability, financial viability and social impact. The level of project typically is likely to involve total feasibility / pre-planning costs of £20,000 - £150,000 maximum (depending on technology and scale) and construction costs of £250,000 - £2,000,000 maximum. # The Landfill Communities Fund VE

The Landfill Communities Fund (LCF) – formerly the Landfill Tax Credit Scheme is an innovative scheme that enables operators of landfill sites to contribute money to enrolled Environmental Bodies (EBs) to carry out projects that meet environmental objects contained in the Landfill Tax Regulations. The ENTRUST organisation regulates the LCF on behalf of HM Revenue & Customs. Organisations wishing to apply for funding through the scheme need to be registered with ENTRUST go to: <u>http://digbig.com/5bcbxw.</u> There are six main areas of work that can be undertaken when utilising LCF monies, these are called the 'objects'. The relevant objects are as follows:

- The remediation or restoration of land which can not now be used because of a ceased activity that used to take place there.
- The reduction, prevention or mitigation of effects of pollution that has resulted, or may result, from an activity which has now ceased.
- The provision, maintenance or improvement of a public park or other general public amenity.
- The conservation of a specific species or a specific habitat where it naturally occurs.
- The repair, maintenance or restoration of a Place of Worship or a Place of Architectural Importance.

Funding can range from £500 - £500,000 and depends entirely on the individual scheme applied for. The most common way to receive funding is to approach a Distributive Environmental Body (DEB). #### Monmouthshire Natural Assets Project CC

Fully funded capital grants (up to £2,000 per project) are available to help support the enhancement and restoration of identified Local Wildlife Sites in <u>Monmouthshire</u>. Local Wildlife Sites are areas considered to be of particular conservation value because of the habitat or variety of species they support. The grant is available to the owners of such sites for projects that help secure their long term sensitive management and conservation.



Examples of projects include stock-proof fencing, restoring traditional field boundaries, works to control invasive species, small specialised machinery / tools purchase. <u>Please</u> note the scheme is now closed. For further details please go to: <u>http://digbig.com/5bhgjs</u>

# EU - LIFE+ ■ CS ■ CV

The LIFE programme is the EU's funding instrument for the environment. The general objective of LIFE is to contribute to the implementation, updating and development of EU environmental policy and legislation by co-financing pilot or demonstration projects with European added value. LIFE began in 1992 and to date there have been three complete phases of the programme During this period, LIFE has co-financed some 3104 projects across the EU, contributing approximately  $\leq 2.2$  billion to the protection of the environment. The current phase of the programme, LIFE+, runs from 2007-2013 and has a budget of €2.143 billion. Calls for proposals are issued annually and the total budget available for this year's call is €276.7 million, of which over €21.5 million has been allocated to the UK. Proposals must be eligible under one of the programme's three components: LIFE+ Nature and Biodiversity, LIFE+ Environment Policy and Governance, and LIFE+ Information and Communication. # Plug-in Van Grant Scheme WE

This Central Government initiative enables motorists purchasing a qualifying ultra-low emission van to receive a grant of 20% towards the cost of the vehicle, up to a maximum of £8,000. The plug-in van grant has been designed to help make the whole-life costs of a qualifying van more comparable with petrol or diesel equivalents. #### The Rural Development Plan for Wales 2007-2013 CS AE CV LS

The Rural Development Plan (RDP) for Wales 2007-2013 is part of a joint Welsh Government and European Union (EU) strategy. The Plan is being delivered through a number of schemes called 'Axes'. Axes 1 and 2 (and part of Axis 3) are mainly aimed at supporting families in Wales and are concerned with 'agriculture and forestry', 'environment and countryside', but Axes 3 and 4 are concerned with quality if life in rural areas and locally based approaches to rural development.

- **Axis 3** aims to improve the quality of life in rural communities by supporting basic services for the rural economy and population, village renewal, conservation and upgrading of the rural heritage and training for rural economic actors.
- Axis 4 uses the LEADER approach to engage grass-roots communities and to encourage the generation of new innovative ways to sustain rural development in Wales in the longer term.



Funding through Axes 3 and 4 may be available for project work locally. To find out if your project is eligible you will firstly need to find out if it is located in a designated 'rural' area and then you will need to contact the organisation responsible for delivering the programme. # SITA Enhancing Communities Programme

Enhancing Communities is the name of SITA Trust's funding programme for community improvement projects. The fund is supported through the Landfill Communities Fund. It supports projects that make physical improvements to community leisure facilities and historic buildings & structures. Not for profit organisations, community groups, parish councils, local authorities and charities within the <u>Haverfordwest area</u> can apply. The programme offers two schemes a Core Fund for grants up to £60K and a Fast Track Fund for grants up to £20K. #### SITA Trust - Enriching Nature Programme 2014 CS CV WE

SITA Trust's Enriching Nature Programme provides funding for year long biodiversity conservation projects that focus on a single species or habitat present on the list of priority species and habitats in England and Wales, with awards of up to £75,000. Applications of a value up to £25,000 are considered as small grant applications. Applications to the Enriching Nature Programme are considered once a year with a deadline in February and notification of the outcome in June. Expressions of interest our now being considered and applicants are being encouraged to get in touch before the deadline of 5.00pm on <u>6th</u> <u>December 2013</u>. If SITA Trust believes that a project idea is worth progressing to a full application applicants will be invited to submit a full application by 5.00pm on 3rd February 2014. #### Snowdonia National Park Authority - Small Community Projects Fund

The Small Community Projects Fund is aimed at helping people living within the National Park to start projects which will benefit both their communities and local environment. The Welsh Government is offering up to 100% grants to projects (large and small) which help people to enjoy the waters of Wales. Minimum grant is £5,000. The emphasis will be on supporting new capital and other works improving bank-side facilities, signage, off road parking, etc. This can also include facilities designed to meet the needs of disabled people.

# WRAP Cymru – Recycle on the go WE SD

WRAP Cymru has opened up a new grant opportunity for organisations that are interested in introducing a recycling service for their visitors. Up to £50,000 in grant aid, plus expert guidance to help choose the right recycling service, is on offer. The scheme is aimed at the following kinds of venues; sports, leisure and arts venues, tourist attractions, transport hubs (e.g. railway stations), colleges, museums and hospitals. #### WREN Biodiversity Action Fund CV

WREN's Biodiversity Action Fund (BAF) is an annual grant programme designed to deliver projects via the Landfill Communities Fund in certain designated local authority areas, in Wales these are; Anglesey, Carmarthenshire, Conwy, Denbighshire, Flintshire, Neath Port Talbot, Swansea and Wrexham. A project's primary aim must be the management, restoration or re-creation of one or more priority habitats and their dependent species to help achieve national, regional or local biodiversity targets. Part of a project site must be within 10 miles of a current or old landfill site. Grants of between £75,000 and £250,000 are available and projects can last for up to 5 years. WREN will consider 100% funding of eligible costs. Applications can involve more than one site where there are clear and defined links between sites e.g. heathlands on Anglesey. Potential applicants are strongly advised to seek advice and support through the relevant LBAP partnership/s and

This programme will fund capital and revenue projects that encourage co-ordinated action by people who want to make their communities better places to live. It supports local and regional projects throughout Wales that focus on; revitalising communities, improving community relationships, or enhancing local environments, community services and buildings. The main aim of the programme is to bring people together to create real improvements to communities and the lives of people most in need. The emphasis is on

# Heritage Lottery Fund WE SD

The Heritage Lottery Fund (HLF) sustains and transforms a wide range of heritage though innovative investment in projects with a lasting impact on people and places. HLF awards a range of grants from £3,000 upwards via the following programmes:

- The **Sharing Heritage** programme is for any type of project related to national, regional or local heritage in the UK and will disburse grants in the range £3,000 to £10,000.
- **Heritage Grants** (Grants above £100,000) This is their main programme for grants over £50,000 for all kinds of heritage that relate to the national, regional and local heritage of the UK. It is open to all not-for-profit organisations.
- Our Heritage (£10,000 to £100,000) This is their general small grants programme for all types of heritage projects. It is a flexible programme particularly designed for voluntary and community groups and first-time applicants.
- **Young Roots** (£10,000 to £50,000) This programme is for projects led by young people. It aims to involve 13-25 year-olds in finding out about their heritage, developing skills, building confidence and promoting community involvement.
- **Townscape Heritage Initiative** (£500,000 to £2,000,000) Townscape Heritage Initiative makes grants that help communities to regenerate Conservation Areas displaying particular social and economic need.
- **Parks for people** (£100,000 to £5million) Parks for People is for whole park projects that support the regeneration of existing designed urban or rural green spaces, the main purpose of which is for informal recreation and enjoyment.
- Landscape Partnerships (£250,000 to £3million) This programme supports schemes that are led by partnerships of local, regional and national interests, which aim to conserve areas of distinctive landscape character throughout the UK.
- Skills for the Future (£100,000 to £1million) Skills for the Future funded projects which provide paid training placements to meet a skills gap in the heritage sector, and fully support trainees to learn practical skills.



 Grants for Places of Worship (From £10,000 to £250,000) Funding for urgent, highlevel repair work to listed places of worship. The scheme is managed separately in each of the four countries of the UK.
