#### Introduction

In 2020, Flintshire County Council consulted on proposals relating to Active Travel improvements, Green Infrastructure investments and traffic measures to aid the existing traffic flow along the B5129 Shotton (Brook Road to Shotton Lane). Following a review of the proposals, Flintshire County Council are holding a further public consultation in order to provide residents, businesses and the wider population with an opportunity to comment on the proposals.

#### **Scheme Consultation**

This consultation document is focused on the B5129 Chester Road East from Brook Street, to Chester Road West, Shotton Lane Junction.

The consultation period is open until midnight of 14<sup>th</sup> August 2022.

Two information events will be held where visitors will be able to view and comment on the proposals (details below).

# Why are the measures along Shotton High Street needed?

Shotton High Street is an important travel corridor providing key strategic links to areas of employment, education and services. However, for those who live, work or regularly travel through Shotton, accessing local amenities either by car, cycle or on foot has historically been impeded by traffic congestion and instances of conflict between pedestrians and cyclists on the footways.

The Active travel (Wales) Act 2013, places a duty on Welsh Authorities to deliver year on year active travel improvements across their respective Counties. Shotton High Street has been identified as a key corridor for Active Travel improvements due to its strategic links to areas of employment, education and services.

In addition to the Active Travel Measures, and funded by the Welsh Government's Greening Fund and the County Council's Regeneration Service, the scheme will also benefit from the introduction of green infrastructure investments on both the High Street and adjacent car parks serving the Town Centre. Measures will include tree pits, rain gardens and green bus stops.

Other traffic management measures aimed at improving traffic flow and reducing congestion are also being considered, which include the introduction of designated right turning lanes and changes to some existing No Entry/ One Way in the residential streets off the main high street.

# Construction

Although the proposed changes have the potential to greatly improve the quality of life for residents as well as offering alternative green travel options for local journeys with obvious benefits for public health and the local environment, as with all such improvement schemes, there would however, be a level of unavoidable disruption to implement the changes. Should the scheme progress to construction, it is anticipated that works would take approximately 11 months to complete and would require the use of temporary traffic lights on the B5129, 24 hours a day, 7 days a week.

#### Scheme details

The proposals consist of:

- Hybrid Cycle lanes (bi-directional) extending along the B5129 from Brook Road to Shotton Lane
- Green infrastructure (Trees, landscape and green bus stops)
- Traffic Measures (introduction of designated Right Turn lanes & changes to existing No Entry/One Way provisions
