

NOTICE OF PROPOSAL

The Flintshire County Council (B5123, Halkyn) (Restricted Road, 20mph, 30mph and 40mph Speed Limits) Order 202x

The Flintshire County Council (hereinafter referred to as "the Council") in exercise of its powers under Section 81, 82, 83 and 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the "Act of 1984") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

- a) To impose a speed limit of 20mph on the length of roads specified in Schedule 1 to this notice.
- b) To impose a speed limit of 30mph on the length of roads specified in Schedule 2 to this notice.
- c) The proposed Order if made will revoke The Flintshire County Council (B5123 Berth Ddu to Springfield Hill) (Restricted Road, 30 mph, 40mph Speed Limit and Revocation) Order 2016 in its entirety.

SCHEDULE 1 **20mph Speed Limit**

B5123, Rhosesmor: From a point 123 metres south east of its junction with Shones Lane, to a point 230 metres north west of its junction with Shones Lane.

SCHEDULE 2 **30mph Speed Limit**

B5123: From a point 230 metres north west of its junction with Shones Lane to a point 292 metres north east of Pentre Road/B5123 Junction.

C72 adjacent to St Marys Church- from its junction with the B5123, to a point 249 metres west of its junction with trunk Road (A55), a distance of 548 metres.

Pen Lan Lane – from its junction with the B5123, to its junction with the C72.

The Flintshire County Council (hereinafter referred to as "the Council") in exercise of its powers under Section 81, 82, 83 and 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the "Act of 1984") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. In this Order except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
2. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the length of road specified in the Schedule 1 to this Order.
3. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the length of road specified in the Schedule 2 to this Order.
4. The road specified in Schedule 3 to this order, shall become a Restricted Road for the purposes of Section 81 of this Act.
5. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the length of road specified in the Schedule 4 to this Order.
6. The proposed Order if made will revoke The Flintshire County Council (B5123 Berth Ddu to Springfield Hill) (Restricted Road, 30 mph, 40mph Speed Limit and Revocation) Order 2016 in its entirety.
7. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
8. This Order shall come into operation on the xxth xxxxxx 202x and may be cited as The Flintshire County Council (B5123, Halkyn (Restricted Road, 20mph, 30mph and 40mph Speed Limit) Order 202-.

**SCHEDULE 1
20mph Speed Limit**

B5123, Rhosesmor: From a point 123 metres south east of its junction with Shones Lane, to a point 230 metres north west of its junction with Shones Lane.

**SCHEDULE 2
30mph Speed Limit**

B5123: From a point 230 metres north west of its junction with Shones Lane to a point 292 metres north east of Pentre Road/B5123 Junction.

C72 adjacent to St Marys Church- from its junction with the B5123, to a point 249 metres west of its junction with trunk Road (A55), a distance of 548 metres.

Pen Lan Lane – from its junction with the B5123, to its junction with the C72.

SCHEDULE 3
Restricted Road

Halkyn Village Road - from its junction with the B5123, for a distance of 405 metres in a north-westerly direction.

Windmill Road - from its junction with the B5123, for a distance of 480 metres in a north- westerly direction.

Unnamed link Road – From its junction with Halkyn Village Road, to its junction with Windmill Road for its entire length.

SCHEDULE 4
40mph Speed Limit

Windmill Road (U190) – From a point 480 metres north west from its junction with the B5123, for a distance of 781 metres in a north-westerly direction.

The Flintshire County Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 82(2)(b), 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter referred to as the "Act of 1984") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. In this Order except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
2. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour, on the lengths of roads specified in Schedule 1 to this Order.
3. The lengths of roads specified in Schedule 2 to this Order, shall become Restricted Roads, for the purposes of Section 81 of the Act of 1984
4. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour, on the length of road specified in Schedule 3 to this Order.
5. The County Council of Flint Order 1971 (No 1) (40mph Speed limit)
The County Council of Flint Order 1971 (No 4) (40mph Speed limit)
The County Council of Flint Order 1970 (No.5) (40mph Speed limit)
are hereby revoked.
6. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
7. This Order shall come into operation on the 5th August 2016 and may be cited as The Flintshire County Council (B5123 Berth Ddu to Springfield Hill) (Restricted Road, 30mph, 40mph Speed Limit and Revocation) Order 2016

**SCHEDULE 1
30MPH Speed Limit**

- (i) **B5123** - from a point 123 metres south east of its junction with Shones Lane, to a point 202 metres north of its junction with Halkyn Village Road
- (ii) **B5123** - from a point 1132 metres north west of its junction with Halkyn Village Road, for a distance of 369 metres in a north westerly direction.
- (iii) **C72 adjacent to St Marys Church**- from its junction with the B5123, to a point 249 metres west of its junction with trunk Road (A55), a distance of 548 metres.
- (iv) **Pen Lan Lane** – from a point 134 metres south east of its junction with the B5123, to its junction with the C72.

SCHEDULE 2
Restricted Road

- (i) **B5123** - from a point 230 metres north of its junction with Halkyn Village Road, for a distance of 902 metres, in a northerly direction.
- (ii) **Halkyn Village Road** - from its junction with the B5123, for a distance of 405 metres in a north-westerly direction.
- (iii) **Windmill Road** - from its junction with the B5123, for a distance of 480 metres in a north- westerly direction.
- (iv) **Unnamed link Road** – From its junction with Halkyn Village Road, to its junction with Windmill Road for its entire length.
- (v) **B5123** – from a point 1501 metres north of its junction with Halkyn Village Road, to a point 292 metres north east of Pentre Road/B5123 Junction.
- (vi) **Pen Lan Lane** –from its junction with the B5123, for a distance of 134 metres in a south easterly direction.

SCHEDULE 3
40mph Speed Limit

- (i) **Windmill Road (U190)** – From a point 480 metres north west from its junction with the B5123, for a distance of 781 metres in a north-westerly direction.

STATEMENT OF REASONS FOR PROPOSING TO MAKE ORDER

Flintshire County Council propose the following:

- a) To impose a speed limit of 20mph by Traffic Regulation Order, on the length of roads specified in Schedule 1 in the Notice.
- b) To impose a speed limit of 30mph by Traffic Regulation Order, on the length of roads specified in Schedule 2 in the Notice.
- c) Inclusion of roads contained within The Flintshire County Council (B5123 Berth Ddu to Springfield Hill) (Restricted Road, 30 mph, 40mph Speed Limit and Revocation) Order 2016 to be revoked and incorporated within this Order.

The Welsh Government will introduce a national default 20mph speed limit on all restricted roads within Wales from 17th September 2023.

Restricted roads are usually located in residential and built-up areas and have a system of street lighting.


The Authority are reviewing all speed limits within the County, in relation to their suitability to the legislation and the B5123 Halkyn forms part of this.

The existing 30mph speed limit within Halkyn, is made by Traffic Regulation Order (where a system of street lighting does not exist) and by sections of Restricted Road status, (where a system of street lighting is present).


To ensure consistency, the lengths of existing 30mph by Restricted Road status, will be made by 30mph Traffic Regulation Order. These sections of roads, do not meet the criteria for a 20mph speed limit. In addition, an existing stretch of 30mph speed limit in the vicinity of Rhos Helyg Primary School, is proposed to be made to a 20mph speed limit, due to the presence of vulnerable road users at this location.

The Authority continues its responsibility to consider the provision of the convenient and safe movement of motor vehicles and other traffic, and the proposed measures are aimed at ensuring that danger is minimised to road users as well as improving the amenities of the locality.

The proposals are detailed in the Public Notice and are contained in the proposed Draft Order.




