

NOTICE OF PROPOSAL

The Flintshire County Council (B5101 Ffordd Llanfynydd, Unnamed Road 1 and Unnamed Road 2, Llanfynydd) (20mph and 30mph Speed Limit) Order 202x

The Flintshire County Council hereby gives notice that it proposes to make an Order under Section 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, and of all enabling powers, the effect of which will be:-

- a) To impose a speed limit of 20mph by Order on the length of roads specified in Schedule 1 to this notice.
- b) To impose a speed limit of 30mph on the length of road specified in Schedule 2 to this notice.
- c) The Order, if made, will revoke The Flintshire County Council (Ffordd Llanfynydd) (20mph Speed Limit) Order 2023 and The Flintshire County Council (B5101 Llanfynydd) (30mph Speed Limit) Order 2016 in their entirety.

SCHEDULE 1 **20mph Speed Limit**

B5101 Ffordd Llanfynydd, Llanfynydd, from a point 10 metres south east of its junction with the Unnamed Road 2, situated to the west of the B5101 Ffordd Llanfynydd, for a distance of 34 metres in a North westerly direction.

Unnamed Road 1, Llanfynydd, situated to the east of the B5101 Ffordd Llanfynydd:
From its junction with the B5101 Ffordd Llanfynydd at a point between the properties known as Archway House and Chapel House for a distance of 33 metres in an easterly direction.

Unnamed Road 2, Llanfynydd, situated to the west of the B5101 Ffordd Llanfynydd:
From its junction with the B5101 Ffordd Llanfynydd at a point between the properties known as Llys Awel and New Millward House for a distance of 160 metres in a westerly direction.

SCHEDULE 2 **30mph Speed Limit**

B5101 Ffordd Llanfynydd: from a point 24 metres north west of its junction with the unnamed road 1 situated to the east of the B5101 Llanfynydd for a distance of 367 metres in a north-westerly direction.

2. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of roads specified in the Schedule to this Order.
3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
4. This Order shall come into operation on the 8th July 2016 and may be cited as The Flintshire County Council (B5101 Llanfynydd) (30 mph Speed Limit) Order 2016.

**SCHEDULE
30 MPH Speed Limit**

B5101 Ffordd Llanfynydd: from a point 21 metres south east of its junction with the un-named road situated to its east side between the properties known as Archway House and Chapel House, for a distance of 367 metres in a north-westerly direction.

Un-named road situated to the east of the B5101 Ffordd Llanfynydd: From its junction with the B5101 Ffordd Llanfynydd at a point between the properties known as Archway House and Chapel House for a distance of 33 metres in an easterly direction.

Un-named road situated to the west of the B5101 Ffordd Llanfynydd: From its junction with the B5101 Ffordd Llanfynydd at a point between the properties known as Llys Awel and New Millward House for a distance of 160 metres in a westerly direction.

Unnamed Road 1, Llanfynydd, situated to the east of the B5101 Ffordd Llanfynydd: From its junction with the B5101 Ffordd Llanfynydd at a point between the properties known as Archway House and Chapel House for a distance of 33 metres in an easterly direction.

Unnamed Road 2, Llanfynydd, situated to the west of the B5101 Ffordd Llanfynydd: From its junction with the B5101 Ffordd Llanfynydd at a point between the properties known as Llys Awel and New Millward House for a distance of 160 metres in a westerly direction.

STATEMENT OF REASONS FOR PROPOSING TO MAKE ORDER

Due to the length of roads contained within Schedule 1 of this proposed Traffic Regulation Order being in a peripheral area that has no street lighting present for the full extents. a 20mph Traffic Regulation Order is proposed, as these roads support the criteria for the suggested advertised speed limit.


The existing 30mph speed limit on the length of road specified in Schedule 2, will be incorporated into the new Traffic Order.

The Authority continues its responsibility to consider the provision of the convenient and safe movement of motor vehicles and other traffic, and the proposed measures are aimed at ensuring that danger is minimised to road users as well as improving the amenities of the locality.


The proposals are detailed in the Public Notice and are contained in the proposed Draft Orders.






