THE FLINTSHIRE COUNTY COUNCIL (WELL STREET, BUCKLEY) (PROHIBITION OF DRIVING) (EXCEPT FOR CYCLISTS) ORDER 202X


The Flintshire County Council proposes to make an Order, under Section 1, 2 and 3 of the Road Traffic Regulation Act 1984, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, the effect of which will be:

- 1) To prohibit any Motor Vehicle Except for pedal cyclists from proceeding through Well Street, Buckley, from a point approximately 220 metres south west of its junction with Bryn Awelon, Buckley.

The Flintshire County Council in exercise of its powers under Sections 1, 2 and 3 of the Road Traffic Regulation Act 1984, ("the Act of 1984") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

- 1) To prohibit any Motor Vehicle Except for pedal cyclists from proceeding through Well Street, Buckley at a point .
- 2) Nothing in Article 1 of this Order, shall apply so as to prevent any person from causing any vehicle to proceed in the length of road referred to in that Article, if the vehicle is :-
 - a) To gain access to adjoining premises;
 - b) In an emergency for Fire Brigade, Ambulance or Police purposes;
 - c) a pedal cycle, which is not a motor vehicle;
 - d) In connection with the carrying out of-
 - i) The maintenance, improvement or reconstruction of the said length of road;
 - ii) The laying, erection, alteration or repair in, or on land adjacent to the said length of road, of any sewer, main, pipe or apparatus for the supply of gas, water or electricity or of any electronic communications network as defined in the Communications Act 2003;
 - iii) Building, industrial or demolition operations;
 - e) In the service of a local authority, public utility company or the Environment Agency in pursuance of statutory powers or duties;
 - f) The vehicle to be used for the purposes of delivering or collecting postal packets as defined in Section 125 of the Postal Services Act 2000.
- 3) The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
- 4) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

5) This Order shall come into operation on the XX 202X and may be cited as The Flintshire County Council (Well Street, Buckley) (Prohibition of Driving) (Except for Cycles) Order 202x.

STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER


Flintshire County Council propose to introduce a Prohibition of Driving, Except for Pedal Cyclist restriction on Well Street, Buckley.

Access to Well Street, will be restricted to through traffic, except for pedal cyclists and pedestrians from a point approximately 220 metres south west of its junction with Bryn Awelon, Buckley.

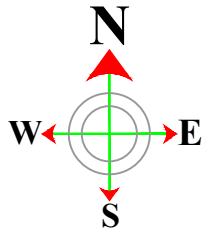
This restriction is proposed in response to the new housing development and is intended to deter excessive use of the surrounding rural lane network. It will help manage traffic more effectively, improve road safety and encourage active modes of travel such as walking and cycling.

The proposals are detailed in the Public Notice and are contained in the proposed Draft Order.

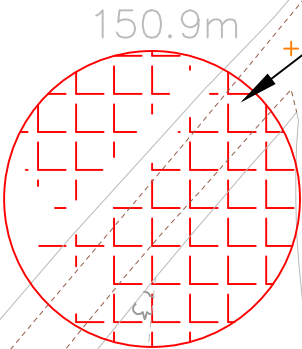
