**Notice of Proposal to Construct a build-out with priority system at  
Glan-yr-Afon, Holywell, Flintshire**

**NOTICE** is hereby given by the Flintshire County Council pursuant to Section 90G of the Highways Act 1980, that it intends to construct a build-out with priority system pursuant to Section 90G of the said Act in the road mentioned in the Schedule to this Notice.

This proposal will consist of a build-out with priority system between the White Lion Public House and Glan Yr Afon Cottages, Glan-yr-afon, and will in all respects comply with the provisions of The Highways (Traffic Calming) Regulations 1999.

**Reason for Proposal:** The build-out will provide a natural break in traffic flow and reduce vehicle speeds, significantly enhancing pedestrian safety. By narrowing the carriageway and improving driver awareness, the feature creates a safer, more comfortable environment for pedestrians in an area where there is no formal footway. This design encourages greater pedestrian use of the highway, improves accessibility for all users, and contributes to a calmer, more pedestrian-friendly street environment.




