

THE FLINTSHIRE COUNTY COUNCIL
(OFF-STREET PARKING PLACE - MOLD) (CIVIL ENFORCEMENT AND CONSOLIDATION)

ORDER 20--

Notice is hereby given that Flintshire County Council ("the Council") proposes to make an Order in exercise of its powers under Sections 32, 34 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ('the 1984 Act') and The Traffic Management Act 2004 and of all other enabling powers, the effect of which will be the provision of amending the levels of charges for car parking in Mold, and other provisions contained therein. 
