

NOTICE OF PROPOSAL

The Flintshire County Council (A548 Sealand Road, Sealand) (40mph Speed Limit) Order 202x

The Flintshire County Council hereby gives notice that it proposes to make an Order under Section 84 of the Road Traffic Regulation Act 1984, and of all enabling powers, the effect of which will be:-

- a) To impose a speed limit of 40mph on the length of road specified in the Schedule to this notice.

SCHEDULE 40mph Speed Limit

A548 Sealand Road, Sealand:

From a point 100 metres north west of its junction with Western Avenue, to the boundary of Flintshire with Chester West and Cheshire as shown on Map Schedule P15. The boundary being located 12 metres north west of its junction with Western Avenue, Blacon

The Flintshire County Council (hereinafter referred to as “the Council”) in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the “Act of 1984”) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. In this Order except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order
2. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the length of road specified in the Schedule to this Order and on Map Schedule P15
3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
4. This Order shall come into operation on the xxth xx 202- and may be cited as The Flintshire County Council (A548 Sealand Road, Sealand) (40mph Speed Limit) Order 202x

STATEMENT OF REASONS FOR PROPOSING TO MAKE ORDER


Following a request, a Speed Limit Assessment was undertaken on the length of A548 Sealand Road, Blacon, north west of its junction with Western Avenue, to the boundary of Flintshire with Chester West and Cheshire.

This assessment recommends the reduction of the existing 50mph speed limit to 40mph from a point 100 metres north west of its junction with Western Avenue Blacon, to the boundary of Flintshire with Chester West and Cheshire.

Safety concerns have been raised due to the existing Bus stop in this location and also the busy junction at Western Avenue.


The Authority continues its responsibility to consider the provision of the convenient and safe movement of motor vehicles and other traffic, and the proposed measures are aimed at ensuring that danger is minimised to road users as well as improving the amenities of the locality.

The proposals are detailed in the Public Notice and are contained in the proposed Draft Order.


