

## STATUTORY NOTICE

## **Proposal to Reorganise the Catholic Education Provision in Flintshire**

To create a single 3-18 Catholic school within Flintshire by:

- 1. Discontinuing St Anthony's Catholic, St David's Catholic and St Mary's Catholic primary schools, and also St Richard Gwyn Catholic secondary school
- 2. Creating a single all-through 3-18 Catholic education school

Notice is given in accordance with section 43 of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code 2018 that Flintshire County Council, having consulted such persons as required, proposes to discontinue the following voluntary aided schools:

- St Anthony's Catholic Voluntary Aided Primary School, High Street, Saltney CH4 8SG.
- St David's Catholic Voluntary Aided Primary School, St David's Lane, Mold CH7 1LH.
- St Mary's Catholic Voluntary Aided Primary School, Ffordd Llewelyn, Flint CH6 5JZ.
- St Richard Gwyn Catholic Voluntary Aided High School, Albert Avenue, Flint CH6 5JZ

Notice is also given in accordance with Section 41 of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code 2018 that the Catholic Diocese of Wrexham and Flintshire County Council, having consulted such persons as required, propose to establish a new Englishmedium Catholic Voluntary Aided school for girls and boys aged 3-18 years (hereinafter referred to as "the new school"). 'Voluntary Aided' category schools are church schools and the Diocese contributes to the building costs and has a substantial influence on the running of the school. The Governing Body employs the staff and sets the admissions criteria. No provision will be made for either selection by aptitude or pupil banding

The new school will be located at Ffordd Llewelyn / Albert Avenue, Flint CH6 5JZ.

The overall capacity of the new school will be for 1185 full-time pupils. Capacity will be divided between 315 full-time primary pupil places and 750 secondary full-time pupil places. Sixth-form accommodation will be provided for 120 part-time pupils. Nursery accommodation will be provided for 45 part-time pupils. For the purposes of school admissions, there will be a published admission number of 45 for entry of full-time pupils into the reception year group, as well as an admission number of 150 for entry of full-time pupils into Year 7.

If the current proposal is agreed and implemented, St David's and St Mary's Catholic Primary Schools, as well as St Richard Gwyn Catholic High School will discontinue on 31 August 2026. The governance structure of the new all through school will start as of 01 September 2026. In effect, the 3-18 school will be established at the existing sites of St David's, St Mary's and St Richard Gwyn respectively and will transfer to the new building when ready.

It is important to note that St Anthony's Catholic Voluntary Aided Primary School, High Street, Saltney CH4 8SG is proposed to close 31 August 2026 and will not be part of the proposed new school.

- Venerable Edward Morgan English-Medium Catholic Voluntary Aided Primary School, Caernarfon Close, Shotton CH5 1AR
- St Winefride's English-Medium Catholic Voluntary Aided Primary School, Whitford St., Holywell CH8 7NJ
- The New English-Medium Catholic Voluntary Aided 3-18 School, Ffordd Llewelyn/Albert Avenue, Flint CH6 5JZ

This is however subject to parental preference and subject to available places. Parents may express a preference for the said schools, or indeed another school, and the Admitting Authority will comply with

any such expressed preference subject to the School Standards and Framework Act 1998, Section 86 (3).

Home to school transport arrangements for pupils attending the new school and for those transferring to an alternative school, including those which transfer to an alternative school not listed above, shall be dealt with in reference to the Flintshire County Council's Home to School Transport Policy. The Catholic Diocese of Wrexham and Flintshire County Council undertook a period of consultation before deciding to publish this proposal.
